ITS FOUNDERS ENVISIONED AN ORGANIZATION THAT WOULD MONITOR THE COMMUNITY'S GREATEST NEEDS AND RALLY THE RESOURCES NEEDED TO FILL THOSE NEEDS. EPCF HAS AWARDED \$1.9 MILLION. IN GRANTS TO 60-PLUS ORGANIZATIONS. GRANTS TOTALING MORE THAN \$278,000 WERE AWARDED THE PAST YEAR-HELPING SENIORS, CHILDREN, DISABLED PERSONS, AND NEW IMMIGRANTS.
